135 In Attendance At 2004 Clay Center High School Alumni Banquet

The Clay Center High School Alumni Banquet was held on Saturday, May 29, 2004 in the high school gymnasium with 135 past graduates and guests present. President Jeremy Anderson gave the welcome and recognized the graduating class of 2004. President Anderson led the assembly in the Pledge of Allegiance, which was followed by the invocation given by John Green, Senior Minister of the Clay Center Christian Church. The banquet was catered by the Sutton American Legion and dinner music was provided by Ben Northrop, Class of 1999. Following the meal CCHS Music Director Ralph Southern accompanied Katie Scoville who provided the evening's entertainment.

President Anderson introduced Principal Jim Bovee, who gave an update of the school's progress in the past year. He recognized the deep history and roots that the alumni association has in the school and all the memories they have provided for today's students. He shared his thoughts about the future of our school and reminded all in attendance that, "We must educate our students for their future, not our past." He stressed the importance of reading, foreign language, technology, problem solving and the ability of our graduates to function in today's society. He recognized retiring staff member Cliff Heftie for his 40 years of dedicated teaching in the school's science program. He then introduced Steven Shackelford who thanked the assembly for their generous support of the Clay Center Public School Endowment, which continues to strive to assist the school district in meeting the needs of all students. Members of the Endowment Committee will continue to communicate with alumni members in an effort to reach out to everyone who has an interest in the school's future.

Cliff Heftie, senior class sponsor, introduced the Class of 2004, which had 3 of the 24 members present. He shared stories of his 40-year teaching experience and also gave recognition to President Anderson for his recent graduation, with honors, from Hastings College.

The business meeting was called to order and minutes were read by Vice President/Secretary Stacey Repp Godtel. Fae Unterseher gave the Permanent Treasurer's report and thanked members for making it another successful year. She also reported that expenses are still exceeding the income generated from dues and that the officers will continue to work on this problem. Income from the fall concession stands has offset some of the expenses and it is hoped that the association will continue to sponsor the stands.

Old business consisted of a report from President Anderson regarding the CCHS Alumni Basketball Tournament. The possibility of organizing the event depends upon whether or not interest is shown. Please contact Jeremy Anderson if you would like to see this happen.

New business consisted of a short discussion of the alumni dues. It was decided to leave them at \$5.00 for the time being.

Permanent Corresponding Secretary, Sandy Northrop Overturf, reported that of nearly 1,200 invitations sent out this year, only 40 had been undeliverable. She now keeps a book of "lost/status unknown alumni" and would appreciate any help finding information on these members. The book is located at the public library if you would like to help with the search. She reported that interest had been shown in beginning a CCHS Alumni Hall of Fame and that anyone with information as to where to start with this project should contact her.

At this time it will not be possible to publish a new alumni directory, but the association will continue to raise the needed funds to do so and explore various options. She brought to attention the upcoming celebration of the 125th birthday of Clay Center and encouraged those in attendance to share a favorite memory of their days in Clay Center by filling out the form provided by the Fourth of July Committee. The on display, along with memories will be cards of congratulations, at the celebration this coming July 4th.

Sandy continued with an update on the Wish List Project. 4 new gold bars were added to the plaque in the high school hallway following last year's banquet and 5 more will be added this year. With the 2003 donations the association purchased a new 50-cup coffeemaker, 3 banquet tables, another page in the graduation picture display rack and a Quiz Bowl Tournament System for the Elementary, Jr. High and High School teams. Quiz Bowl sponsor, Jeremy Heneger, sent his thanks for the gift, which made such a difference in this year's academic competitions. Sandy reported that the fall Jr. High and Junior Varsity Concession Stands made a profit of \$560.00, which was enough to cover the cost of this year's first class mailings. She thanked the local members for their donations toward inventory for the stands and gave special recognition to the members in attendance that helped run the stands.

Fae returned to the podium to announce this year's scholarship winners, but before doing **SO** made the announcement that the association has received a special legacy for the scholarship program from the Royce and Marie Royce (Class of 1933) and his wife Marie **Deines** Estate. donated \$10,000 to the program, which will be used for many generations to come. Fae went over the history of the scholarship program since it's inception in 1996, the eligibility criteria and application process, plus she stressed the importance of the applicant's research into their family member's history in the community, school and alumni association. Fae announced that the first Royce and Marie Deines Memorial CCHS Alumni Association Scholarship was being awarded to Zachary Tessman. Zach is from a 4generation CCHS graduate family and plans to attend Concordia University this fall where he plans to study toward his goal of becoming a physical therapist. Adam Green, and Carissa Hagemeier, both second-generation graduates, also received alumni scholarships. Carissa plans to attend CCCC in the fall where she will pursue a career in elementary education and Adam will attend Ozark Christian College where he will pursue a Bachelor of Music and Worship degree.
